The YESAB Website

It links to the YESAB Online Registry, which contains copies of assessment-related documents. You will also find contact information for our six Designated Offices and our main Whitehorse office.

Fact Sheets

In order to provide information and answers to some commonly asked questions about assessment processes under the Act, fact sheets are now available for specific subjects. These fact sheets provide general information on the topic and in most cases provide the reader with ways to find additional information.

Fact sheets have been developed on topics which include:

- First Nation Participation in Assessments
- Public Participation in Assessments
- Socio-economic Effects Assessment
- Assessment of Cumulative Effects
- YESAB Public Registry

Proponents' Guides

Those who submit project proposals under the Act are referred to as proponents. They require a higher level of detail than our fact sheets provide. YESAB have developed proponents' guides which describe the specific information related to proposed projects that assessors need in order to conduct assessments. These include a guide for Designated Office evaluations and one for Executive Committee screenings.

Information required in a project proposal includes project location, project activities and description, baseline environmental and socio-economic information for the project area, the identification of potential environmental, socio-economic and cumulative effects, their mitigation and significance. Our guides also include information about the evaluation process that helps proponents understand how to submit proposals, what to expect during an evaluation and how to follow a proposal through the evaluation.



Participation Guide

In order to conduct good assessments under the Act, it is essential that the public is able to participate in and contribute to the assessment process. A public participation guide has been produced so that people know how to get information on assessments, how to submit comments or information, and how to follow assessments.

Confidential Information Guides

The Act has special provisions which allow certain traditional knowledge and sensitive information to be designated as confidential. Guidelines have been produced for both proponents and assessors to ensure that they are aware of the availability of this process for the use and handling of sensitive information.

Assessor Procedural Guides

For those who want to know more about the stages and processes involved in a Designated Office evaluation or an Executive Committee screening, procedural guides for these two types of assessments are available. These documents have been written primarily for assessors, but will be of use to people who would like to know more about the assessment process. The procedural guides pull together all the direction contained in the Act, the Regulations, the YESAB Rules and the Technical Assessment Guidelines about how to conduct assessments.

Technical Assessment Guidelines

The most detailed assessment documents are the Technical Assessment Guidelines. As suggested by the title, these documents have been written in a technical style and so may have a more limited readership. They include detailed rationales, assessment theory and a variety of assessment methodologies. They detail a variety of options to make assessments appropriate for the different types of project proposals that may be submitted. These technical guides also provide detailed direction to ensure assessments are carried out in a consistent manner.
